- 1. The Government of Nepal has received financing from the Asian Development Bank (ADB) towards the cost of **Electricity Grid Modernization Project**. Part of the loan will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
- 2. The **Nepal Electricity Authority** ("the Employer") invites sealed bids from eligible bidders for the Design, Supply, Installation, Integration, Testing and Commissioning of Substation Automation System (SAS) for Existing Grid Substations of six Grid Division offices across Nepal ("the Facilities").
- 3. **Open Competitive Bidding (OCB)** will be conducted in accordance with ADB's <u>Single-Stage: Two-Envelope</u> bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
- 4. Bidders shall have minimum average annual turnover of US\$ 17.85 Million. Bidder shall be a manufacturer of major SAS equipment (i.e. BCU, SCADA, Control and relay panel and Protection relays) since at least last 10 (ten) years and has experience in participation in at least one set contract that has been successfully or substantially completed within the last 10 (Ten) years and that are <u>similar</u> to the proposed contract, where the total value of the Bidder's participation in contract exceeds US\$ 17.85 Million. and the SAS system supplied for above substantians under the mentioned contract shall have been in operation satisfactorily for minimum 2 (Two) years. The similarity of contract is defined in EQC 2.4.1 of the bidding document.-Vol 1.

- 6. To purchase the bidding documents in English, eligible bidders shall:
- Write to address above requesting the bidding documents for PMD/EGMP/GSAPP2– 078/79–01:: Design, Supply, Installation, Integration, Testing and Commissioning of Substation Automation System (SAS) for Existing Grid Substations of Six Grid Division office across Nepal.
- Pay a non-refundable fee of NRs. 20,000 (twenty thousand only) or an equivalent amount in US\$ by bank voucher to the Current Account No. 0010001460000913 (Account Name: NEA, PROJECT MANAGEMENT DIRECTORATE) at the NMB Bank Ltd, Babarmahal, Kathmandu, Nepal.
- 7. Deliver your bid:
- To the address above on or before the deadline: 27th May 2022, 12:00 Hours (Nepal Standard Time).
- Together with a Bid Security with amount indicated in Bidding Document Section 2 Bid data Sheet, Clause ITB 21.1.

Technical Bids shall be opened at the Project Manager's Office 27 May 2022 at 12:30 hours (Nepal Standard Time) in the presence of bidders' representatives who choose to attend, whereas the Financial Bids shall remain sealed and unopened and shall be placed locked. The Financial Bids of only Technically Responsive and Qualified Bidders shall be opened after technical bids evaluation, whereas, the financial bids of those bidders whose technical bids are not responsive and qualified shall be returned unopened after the contract is awarded.

8. When comparing Bids, ADB's **Domestic Preference Scheme** shall be applied in accordance with the provisions stipulated in the Bidding Document.
