The Nepal Electricity Authority (NEA) has received financing from the World Bank toward the cost of the Tender Design, and Preparation of Bidding Documents (Phase A) and has applied for financing from the World Bank toward the cost of the Construction Supervision and Post Construction services (Phase B & C) for the construction of the Upper Arun Hydroelectric Project (UAHEP), and intends to apply part of the proceeds for consulting services.


The consulting services ("the Services") include the Tender Design and Bidding Documents preparation (Phase A: preconstruction services), Construction Supervision (Phase B) and Post Construction Service (Phase C). In particular, the principal activities will include, but not limited to the following:

- Review and update of feasibility study report;
- Preparation of tender design and tender document of the project;
- Assist Employer in tender evaluation, negotiation and contract award;
- Construction supervision and post construction services for the project. These include but are not limited to dam, waterways and powerhouse (including hydro-mechanical, electro-mechanical works).
