Pursuant to ITT Sub-Clause 7.4 of the Tender Document the Pre-Tender meeting was held in the Project office at Rudramati Marg, Setopul, Maitidevi, Kathmandu, on 26 February 2023 at 12:00 hrs. Mr Keshab Shrestha, Project Manager, DSUEP (AIIB) Chair the meeting.

Representatives from the interested tenderer who has intended to purchase the tender documents attended the meeting. The Participant list from the interested Tenderer's side and NEA side is given in the annexure 1.

Mr. Keshab Shrestha, Project Manager, DSUEP (AIIB) gave the opening remarks and welcome all the participants.

Mr. Keshab Shrestha, Project Manager initiated the discussions and explained about the project. Actually the present people didn't raise any queries related to the tender document.

The representatives were requested to submit the queries if any in the written form so that they can be answered effectively and without discrepancy. They requested to increase the deadline for queries submission and accordingly the deadline for final queries submission was set for 28 February 2023. Representatives were told that they will be provided with written clarification of the queries received by the new deadline for queries submission.

The Pre-Tender meeting ended with vote of thanks from the Mr. Keshab Shrestha, Project Manager, DSUEP (AIIB).

Within the deadline set in the Pre-Tender Meeting i.e. 28 February 2023, some of the prospective tenderers have asked some queries regarding the issued tender documents.
