The primary objective of NEA is to generate, transmit and distribute adequate, reliable and affordable power by planning, constructing, operating and maintaining all generation, transmission and distribution facilities in interconnected and isolated sector in Power System of Nepal.

NEA carries out its' functions through the following nine directorates established under Managing Director:

- (b) Generation Directorate
- (c) Transmission Directorate
- (d) Planning, Monitoring and IT Directorate

2. Objective:

The main objective of the proposed DDA is to conduct a detail and comprehensive examination of NEA's financial and other related information with a view to assessing its condition and determine the potential business and various associated risks.

The objectives of proposed study are:
